PARENTAL CONSENT, LIABILITY WAIVER, & MEDICAL RELEASE

AUTHORIZATION TO PROVIDE TREATMENT

I, the parent or legal guardian of the participating child, do hereby authorize and consent to any X-ray examination, anesthetic, medical, or surgical treatment rendered under the general or special supervision of any appropriately licensed member of the medical staff and emergency room staff or an appropriately licensed Dentist on the staff of any acute general hospital or emergency care facility holding a current license to operate a hospital or emergency care facility from the State of California. I understand that this authorization is given in advance of any specific diagnosis, treatment or hospital care being required, but is given to provide authority and power to render care which the aforementioned physician, in the exercise of his/her best judgment, may deem advisable for my child. Further, I understand my child will be participating in inherently dangerous activities and agree to pay for my child's medical expenses. I understand if circumstances exist that allow time to contact me an attempt shall be made prior to rendering treatment to my child, but any of the above treatment will not be withheld if I cannot be reached.

RELEASE FROM LIABILITY

In consideration of the acceptance of the application of my child as a participant in any programs and/or activities of the Long Beach Police Athletic League, I and my child hereby agree to assume all risks attendant upon myself and my child while participating in any Long Beach Police Athletic League programs and/or activities. I and my child hereby waive, release, and discharge any and all claims for damages for death, personal injury, or property damage which I or my child may have, or which may hereafter accrue to me or my child, as a result of my child's participation in the Long Beach Police Athletic League program or activity. I agree to indemnify and hold harmless from liability the Long Beach Police Athletic League, the City of Long Beach, and/or any of their officers, agents, employees, or volunteers by reason of any accident, death, injury, or damages, to persons or property which I or my child may suffer while participating in the Long Beach Police Athletic League program and/or activity. This release is intended to discharge in advance the Long Beach Police Athletic League, the City of Long Beach, and/or any of their officers, agents, employees, or volunteers by reason of any accident, death, injury or damages to persons or property which I or my child may suffer, from and against any and all liability arising out of or connected in any way with my or my child's participation in the Long Beach Police Athletic League program and/or activity, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above. I acknowledge that the City of Long Beach and the permittee/sponsor are not joint sponsors, joint ventures, partners, or otherwise jointly engaged in any Long Beach Police Athletic League programs and/or activities.

VIDEO-PHOTO RELEASE

PARTICIPATION CONSENT

I, the parent or legal guardian of the participating child, do hereby consent to my child's participation in any Long Beach Police Athletic League program and/or activity. I agree that prior to my child's participation in the event or activity, my child and I will inspect the facilities, equipment and areas on or at which the event or activity is to be conducted and, if either of us believe something is unsafe, I will immediately advise the person supervising the event, activity, facility or area. I warrant that my child is in good health and has no physical condition that would prevent him/her from participating in any Long Beach Police Athletic League program and/or activity.
